



**Membership tags are required for all swimming facilities (beaches and floats) and must be visible.**

**\*\*New this year - we are pre-printing stockholder names on the Membership Tags – for those who turn in their request form by March 22 \*\***

Please complete the attached membership & boat tag application. **Drop off** your completed application to the CLPO mailbox (next to the stone pillar on the landing side at 91 Cedar Lake East), **Mail** to CLPO, PO Box 1195, Denville or **email** to [clpo2@optonline.net](mailto:clpo2@optonline.net). Your tags will be delivered or mailed to you.

Membership tags will be issued to all eligible stockholders or their tenants (**not both**) who reside at Cedar Lake on a yearly basis. Stockholders must be in good standing with at least half of the 2019 Share of Expense (\$475) paid to the CLPO to receive tags. **Note: please allow 2 weeks for processing of membership badge requests.**

Each boat requires (1) boat tag. Please place one boat tag on each boat, regardless of whether they are kept on a landing or on private property. Boat tags provide a quick way of notifying boat owners when their boats have been found adrift. **Boat Tags and Membership tags are required by Memorial Day Weekend.**

At landings, untagged boats are subject to removal and a \$100.00 (per boat) reclaim fee assessed.

**Please note that non-Cedar Lake boats are NOT permitted on the lake, even if they belong to stockholders' guests.**

**Your cooperation in adhering to these rules is appreciated as a means to maintain the quality and integrity of the lake and this community.**

**A swimming lesson sign-up form is attached for your convenience** - swimming instructions are given by the swim instructor to members of paid stockholders' families or his/her tenants' families who reside at Cedar Lake during the summer. The swimming program participant's fee covers swim lessons and/or swim team participation. This year's fee is \$45.00 per child with a maximum of \$125.00 per family. **Please make checks payable to the Cedar Lake Property Owners, Inc.** Swim team events are under the supervision of the CLCC. You must also be a paid-up Community Club member in order to participate in swim team.

**For those who meet the deadline by sending in their membership badge application by March 22nd: Badges and boat tags will be available for pickup at the Open Meeting!!**

Due to delays in the permitting process for the East Beach bathroom project, the construction will begin in the Fall after Labor Day.

**As we approach the swim season please keep in mind that during periods of heavy rainfall, one can expect a higher than normal reading of E. coli at the beaches. We will post an advisory on the bulletin board if a reading is in exceedance and will also send an email blast. In conjunction with our lake management and water testing companies, the CLPO Board monitors information regarding water quality and changes can occur due to seasonal weather conditions.**

## MEMBERSHIP TAG RULES

1. **Swimming, ice fishing and ice skating are at your own risk.**
2. **Membership and guest tags are for the use of stockholders in good standing to whom they were issued. Membership tags are not transferable.**
3. **Only stockholders or their tenants who reside at Cedar Lake may be issued tags. Stockholders and tenants are not both eligible for tags. Frequently visiting guests and relatives MUST use guest tags.**
4. **Current year membership tags will be required on all beaches/floats starting Memorial Day weekend.**
5. **Tags must be displayed at all times when using beaches, floats or islands.**  
**Tags are issued-age as of June 1<sup>st</sup>:**  
**For adults (16 years of age or over)** Must be 16 years of age for an adult tag.  
**Ages 13-15 Tag.** Child must be able to swim 25 meters unassisted to attend the beach unaccompanied and can supervise younger children. Must be 13 years of age.  
**Ages 10-12 Tag.** Child must be able to swim 25 meters unassisted to attend the beach unaccompanied but cannot supervise younger children. Must be 10 years of age.  
**Ages 6-9 Tag.** Must be accompanied by an adult or a person 13 years of age or over who is designated as the responsible party. Must be 6 years of age.  
**Under 6 years of age**—No tags issued and must be with an adult or person 13 years of age or over who is designated as the responsible party.
6. **Each stockholder will be issued a maximum of 4 guest tags without charge. If a stockholder requests additional guest tags for the season, a \$10.00 fee/tag will be charged. Maximum allowed is 4 additional guest tags. There is a \$5.00 replacement fee for a lost membership tag or a lost guest tag.**
7. **Current year tags are required for swimming, ice skating and ice fishing. Retain tags if you anticipate ice skating/fishing during the winter. Tags are required for identification.**
8. **Only individualized floatation devices or rafts are allowed within the boundary ropes at the beaches. No oversized rafts are allowed at the beaches.**
9. **Chairs - beach or lounge chairs are restricted to the 3<sup>rd</sup> dock (dock closest to the entrance) or dock area near the dam or the platform near dam or on the sand areas. No chairs should be on the 1<sup>st</sup> or 2<sup>nd</sup> docks.**
10. **Beach Parties: Stockholders can request beach party tags at \$1.00 for each tag. AT LEAST ONE WEEK ADVANCE NOTICE IS REQUIRED FOR PARTY ARRANGEMENTS. The stockholder who requests the party tags must hire a certified lifeguard (through our Swimming and Water Safety Chairperson) for every 15 party tags purchased and be in attendance for the duration of the party. The tag(s) should be returned within one week of the party date. Party tags will be issued at the CLPO Board's discretion.**
